THIS AGREEMENT made at Dombivli, this 1st Feb 2023 between

Shirodkar Hospital Trust's, having its Educational Institute at Vadavli, Dombivli (east) 421 204, Dist Thane.

And

M/s. Ganesh Transport (The Contractor)
a proprietary concern, having its office at Laxmi Niwas, Datta Nagar, Behind Datta Mandir, Near Pragati College, Dombivli (east), Dist. Thane (which expression unless repugnant to context shall mean include its successors and assigns) of the other part.

WHERE AS the Institute was looking for a leading transport contract for transport of Student and employees 'to and fro' between the AIMS Hospital Station to Vadavli and such other points required by the Institute.

M/s. Ganesh Transport is offering specialised transport service to Various Industrial Organisations in Mumbai as well as Thane District has offered to make available its specialised transport services for transport in Student and employees between AIMS Hospital and Dombivli Railway Station as shown in annexure of this Agreement.

WHEREAS the Institute in order to protect the interest to the student and employees, their Safety and Security and to ensure efficient transport service to enable the student and employees to report for their work punctually and time has agreed to sign this agreement.

It is hereby agreed by and between the parties as under:

- 1) The Contractor shall provide their specialised transport services for transport of student and employees of the Institute by providing buses in good condition road worthy and duly licensed by the Regional Transport Authority and driven by qualified and experienced drivers.
- 2) The Contractor shall provide for the aforesaid specialised transport services rendered to the Institute a 30 seaters 2 buses from 01st Feb 2023 to 1st Jan 2033 and employ such number of drivers/ cleaners and all other categories of employees including Managers, Supervisors, Helpers and to give proper qualitative, complete and efficient specialised transport services for the students and employees engaged in the Institute.
- 3) That the student and employees engaged by the Contractor for such purposes would be required to undergo such periodic medical examination as may be deemed fit and proper by the Institute for which the Contractor would be required to pay necessary charges and only those student and employees of the Contractor who are found medically fit would be permitted to be engaged for rendering such specialised services to the Institute.
- 4) The Contractor shall be fully responsible for the behaviour and conduct of their student and employees while on duty for rendering transport service to the Institute and the Contractor shall ensure that they will maintain proper decorum and decency while rendering such specialised services.
- 5) That the Contractor shall maintain and preserve all the registers, books and records required to be maintained and preserved under various labour laws which they shall make available for inspection to the authorised representatives of the Institute as and when required and as provided under the labour laws.
- 6) The Contractor shall give and render complete specialised services of transport of student and employees by buses at all times as per schedule.
- 7) The Contractor for rendering such specialised services to the Institute shall arrange for their own equipment, apparatus and tools required for rendering such specialised transport services to the Institute.
- 8) The Contractor shall maintain highest standards while rendering such specialised transport services for transport of Students and employees between AIMS Hospital and Dombivli Railway Station and such other point as referred to in Annexure in this agreement.
- 9) It shall be the responsibility of the Contractor to pick up the Student and employees from various points as per Annexure.
- 10) It shall be the responsibility of the Contractor to ensure Safety and Security of the Students and employees of the Institute, while using such transport facilities and the Contractor shall be providing such transport facility and service at his own risk.
- 11) The Contractor shall cover adequately the vehicles, drivers, cleaners and the Students and employees travelling in the bus under proper insurance including third party insurance
- 12) The Contractor shall provide the bus and transport service on all the days of the month as per the bus stops, shift timings and corresponding bus timing, as per Annexure.

13) The Institute shall pay lump sum compensation as per annexure towards transport services for route services, with effect from 01st Feb 2023 providing transport services to our Institute. Such payment shall be made by 25th of subsequent month.

14) It is agreed by and between the parties that above lump sum compensation is fixed with fuel prices as on 01st Feb 2023, i.e. Diesel price as per annexure and any increase beyond minimum Re.1/- will be calculated on a monthly basis and difference will be adjusted or paid accordingly.

15) The Contractor shall raise his monthly bills for the specialized transport services rendered by him, on the Institute, for the services provided in the previous month and the Institute shall clear the said bill on or before the 25th of the next month.

16) It is further agreed by and between the parties that, this agreement has been signed by the Institute with the Contractor for the benefit of their Student and employees.

17) It is further agreed by and between the parties that, the Institute shall not be liable for any financial obligation under this agreement except those, which have been specifically provided herein above.

18) It shall be the responsibility of the Contractor to pick up the Student and employees in time and bring them in time and drop them at the destination point in time as per bus stops, shifts, shift timings and corresponding bus timing as per Annexure.

19) It is further agreed and understood between the parties that, the bus provided for transport of the Student and employees by the Contractor, while rendering such services to the Institute, shall bear Institute's nameplate for proper identification.

20) The Contractor shall ensure that, he would provide buses with proper adequate, comfortable, sitting arrangement and windows, without any leakage of any kind, which would endanger the lives of the employees.

21) The buses should have Emergency Exit openable outward besides main entry door.
