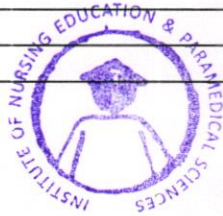

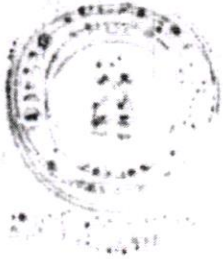

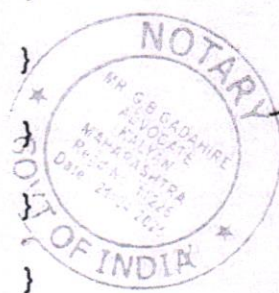

AND WHEREAS the Nursing institute has established a ANM/GNM/P.B.B.Sc(N) and situated at SHT's Institute of Nursing education and Paramedical Science, at Vadavali, Dombivli, Tal-Kalyan, Dist-Thane-421306 (hereinafter referred to as "the said institute") as we our own parent hospital (Private) but we are lagging off with the government hospital facilities for students clinical practice.

AND WHEREAS the SHT's Institute of Nursing Education and Paramedical Sciences have requested to KDMC to permit them to use beds in corporation Hospital at kalyan and Dombivli more particularly described in the First Schedule hereunder written (hereinafter referred to as "the said Hospital") as well as other facilities available in the said Hospital for being utilized by the students of the said institute for training .

AND WHEREAS the Commissioner, KDMC has agreed to permit the SHT's Institute of Nursing Education and Paramedical Sciences to utilize the said beds in the said Hospital, short particulars of which beds are given in the Second Schedule herein under written on certain terms and conditions agreed between the parties hereto.

AND WHEREAS the SHT's Institute of Nursing Education and Paramedical Sciences have agreed to construct within three years from the date of this agreement a fully equipped Hospital consisting of beds with modern sophisticated investigational amenities and facilities at their own cost and adjoining the institute.

AND WHEREAS the parties are desirous of recording the said terms and conditions.

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:-

- 1) In consideration of grant of licence by the government to the SHT's Institute of Nursing Education and Paramedical Sciences to used of the said hospital furniture equipment and incidental services to be provided by the government to the nursing Institute, the SHT's Institute of Nursing Education and Paramedical Sciences shall pay to the government as and by way of licence fee calculated at the rate of Rs. 50/- per day per occupied bed per student used by the institute the said amount of the licence fee shall be paid by the SHT's Institute of Nursing Education and Paramedical Sciences to Kalyan Dombivli Municipal corporation in advance on the first day of January to 31st March each and every year during the subsistence of the license. The balance amount remained after deduction of actual payment as per occupied bed will be carried forward to next year.
- 2) If students examination period is different from institutional training , the nursing Institute needs to pay additional payment of Rs.50/- per day per bed per student.
- 3) In pursuance of the said agreement and in consideration of the Manager, agree to pay the KDMC licence fee at the rate aforesaid at the time and in the manner hereinbefore mentioned, the KDMC hereby grants to the SHT's Institute of Nursing Education and Paramedical

Sciences a license and permission to have access to and use the said only for the purpose of training students of the license institute during the period commencing from the 18th August, 2023 and ending on the 17th August, 2025.

Provided that if KDMC is satisfied that the institute and SHT's Institute of Nursing Education and Paramedical Sciences have duly performed and observed all the terms and conditions of this agreement and have achieved reasonable and/ or significant progress towards the construction on and setting up of their own hospital the KDMC may grant extension of this licence for such a further period and at such licence fee as the KDMC may determine .

4) This License shall extend to the employees, agents, students and such other person as may be lawfully required by the Institute for training the student of the Institute.

5) **The Kalyan Dombivli Municipal Corporation (KDMC) hereby agrees:**

a) That the SHT's Institute of Nursing Education and Paramedical Sciences may use the existing furniture, dead stock and clinical facilities belonging the hospital for the purpose of training students of the institute. If any additional furniture, dead stock and equipment is required by the nursing Institute for training students of the Institute as per the appropriate Councils of India and universities requirements then the same shall be provided, installed and maintained by the Managers at their own costs. Provided that entire medical equipment of the said Hospital shall, at the discretion of the Chief Medical Officer of the said hospital, be available to all the patients of the said hospital.

b) That the Chief Medical Officer of the said hospital shall be responsible for the care of the patients in the said hospitals:

Provided that the exact condition and responsibility of administration, teaching and care of patients shall be worked out and fixed by mutual consultation between the KDMC and the nursing Institute.

Provided also that the decision in this regard by the KDMC on the parties hereto.

6) **The SHT's Institute of Nursing Education and Paramedical Sciences, Dombivli Undertake and agrees.**

a) To use the said 120 beds in the said Hospital for the purpose of teaching its students only and for no other purpose whatsoever.

b) at their own cost and risk to store items of furniture, equipment and property of The SHT's Institute of Nursing Education and Paramedical Sciences in the said hospital after taking prior permission in writing of the Chief Medical officer of the said hospital.

c) The SHT's Institute of Nursing Education and Paramedical Sciences requires any additional staff for the purpose of training programme of the

- d) during this period of this agreement, the staff and students of the Institute who will be in premises of the said hospital, shall always be subject to the disciplinary control of the Chief Medical Officer of the Hospital.
- e) that the KDMC shall be entitled to periodically evaluate the recurring expenditure involved as a result of utilization of facilities of the said hospital by the Institute and if upon evaluation, KDMC is required to incur additional expenditure on that account, then the Institute, shall bear and pay to the KDMC such an additional recurring expenditure.
- f) to pay for or make good at their expense any damage caused or done by any of the students and staff of the Institute to the inmates of the said Hospital and / or its property or any part of said Hospital or any part appertaining thereto to which the staff and students of the institute have access, except fair wear and tear related to the proper use of the said Hospital by the nursing Institute.
- g) to keep at all times the said Hospital premises and its precincts clean, neat and in good sanitary conditions.
- h) not to do or permit to be done anything upon the premises of the said hospital and its precincts which may be nuisance, annoyance and disturbance to the patients and inmates of the said hospital or to the owners, occupiers or residents of other premises in the vicinity.
- i) that the Corporation or any other person authorized by Corporation from time to time shall have the right to inspect the said hospital (including the said beds therein which the SHT's Institute of Nursing Education and Paramedical Sciences are permitted to use) on behalf of the KDMC and the manager, office bearers, staff and the students of the institute shall render to such person full assistance enable person inspect the said hospital. If such person requires the SHT's Institute of Nursing Education and Paramedical Sciences to comply with directions in this behalf, then the SHT's Institute of Nursing Education and Paramedical Sciences shall without demur comply with them.
- j) To comply with all the directions or instructions issued by Government / Corporation from time to time.
- k) The students are not entitled for any remuneration or salary or allowance from Kalyan Dombivali Municipal corporation.
- l) KDMC will not take any responsibility of any student/ teacher getting infection or any other disease while working in hospital.

- 7) The License hereby granted shall not confer on the SHT's Institute of Nursing Education and Paramedical Sciences, staff and students of the institute any rights other than those hereby expressly granted.
- 8) If the SHT's Institute of Nursing Education and Paramedical Sciences fails to pay the fees on the date fixed for payment under these presents or if any whenever there shall be a breach of any of the terms and conditions hereof by the SHT's Institute of Nursing Education and Paramedical Sciences or if the KDMC is satisfied that the SHT's Institute of Nursing Education and Paramedical Sciences have not achieved reasonable or significant progress towards construction and setting up of their own hospital, then the License hereby granted may be terminated by the KDMC by giving to Manager, three months prior notice in writing in that behalf and in the event of such termination or the expiration the SHT's Institute of Nursing Education and Paramedical Sciences shall not be entitled to any damages caused to them or of the building/s or additional floors or improvements built or carried out on the premises of the said hospital by the SHT's Institute of Nursing Education and Paramedical Sciences.
- 9) Without prejudice to any other rights and remedies of the Government arrears of the said license fee shall be deemed to be arrears of the land revenue and as such may be recovered by the KDMC from the SHT's Institute of Nursing Education and Paramedical Sciences as arrears of and revenue under the provisions of the Maharashtra Land Revenue code, in 1966 and any amendments thereof.
- 10) The Licensee (Manager) shall indemnify and keep the licensor indemnified against all cost, charges, losses and damages which the licensor may suffer or incur by virtue or any negligence on the part of licensee which shall effect the licensor (KDMC) and to the reimburse the licensor (KDMC) all such costs, charges or expenses, losses or damages as the case may be, immediately on demand by the licensor (KDMC). The decision of the licensor (KDMC) in this regard shall be final and binding on the licensee and the licensee shall not have any right to dispute the same.
- 11) The licensee SHT's Institute of Nursing Education and Paramedical Sciences shall not entitled to carry out any renovation and interior work in said premises, as per their requirement.
- 12) The licensee SHT's Institute of Nursing Education and Paramedical Sciences shall use the said premises only for its lawful object business purpose. The licensee (Manager) shall not carry out any business in contravention of any law or statute for the time being in force.
- 13) The Licensee SHT's Institute of Nursing Education and Paramedical Sciences shall comply with all rules and regulation and bye laws applied the said premises.
- 14) The licensee SHT's Institute of Nursing Education and Paramedical Sciences shall not allow to private person/ third person in the premises.


1. **Purpose:** The primary objective of this MOU is to outline the roles and responsibilities of both parties involved in the clinical training of GNM / BSc Nursing students.
2. **Duration:** This MOU will be in effect for a period of Three years, commencing on **Jan2025 to Dec 2028** terminating on. It may be renewed or modified by mutual consent of both parties.
3. **Roles and Responsibilities:**
 - A. **SHT's Institute of Nursing Education and Paramedical Sciences :**
 - Select and provide nursing students for clinical posting at Bai Jerbai Wadia Hospital for Children.
 - Ensure that the selected students meet the necessary academic and clinical requirements.
 - Appoint a coordinator to liaise with Bai Jerbai Wadia Hospital for Children for student placement and to address any concerns or issues.
 - B. **Bai Jerbai Wadia Hospital for Children**
 - Provide clinical facilities, resources and supervision for nursing students during their posting.
 - Collaborate with **SHT's Institute of Nursing Education and Paramedical Sciences** to ensure that students meet their clinical objectives.
4. **Confidentiality:** Both parties agree to maintain the confidentiality of any Patient information and sensitive data encountered during the students' Clinical posting.
5. **Termination:** This MOU may be terminated by either party with a written notice of 30 days Notice Period in advance. The termination will not affect the completion of ongoing clinical placements.
6. **Dispute Resolution:** In case of any disputes or disagreements, both parties will engage in good faith negotiations to resolve the issue. If necessary, a mutually agreed-upon mediator or arbitrator may be employed.
7. **Amendments:** Any amendments to this MOU must be made in writing and signed by both parties.
8. **Governing Law:** This MOU shall be governed by and construed in accordance with the laws of Maharashtra.
9. **Liability:** **Bai Jerbai Wadia Hospital for children** will not be held liable for any injuries, accidents, or incidents that may occur to GNM /BSc Nursing students during their clinical posting at the hospital. SHT's Institute of Nursing Education and Paramedical Sciences shall be responsible for providing necessary insurance coverage and taking appropriate measures to address any issues or claims related to student safety. GNM / BSc students are expected to adhere to all hospital safety protocols and guidelines during their clinical posting.
10. **Code of Conduct:**
 - a. GNM / BSc Nursing students are expected to adhere to a high standard of professional conduct while at Bai Jerbai Wadia Hospital for Children. This includes, but is not limited to, maintaining patient confidentiality, showing



- respect for patients, their families, and hospital staff, and following all hospital policies and procedures.
- b. GNM / BSc Nursing students will dress in accordance with hospital dress codes and will wear identification badges at all times.
 - c. Any violation of the hospital's code of conduct or policies may result in disciplinary actions, including the termination of the clinical placement.
 - d. SHT's Institute of Nursing Education and Paramedical Sciences will provide nursing students with guidelines on professional behavior and the hospital's specific code of conduct that they must adhere to during their clinical placement. Students will be required to sign an acknowledgment of these guidelines and code of conduct.

This MOU represents a commitment from both parties to ensure the high-quality education and training of GNM / BSc Nursing students. By signing this document, both parties acknowledge their willingness to abide by the terms and conditions set forth herein.



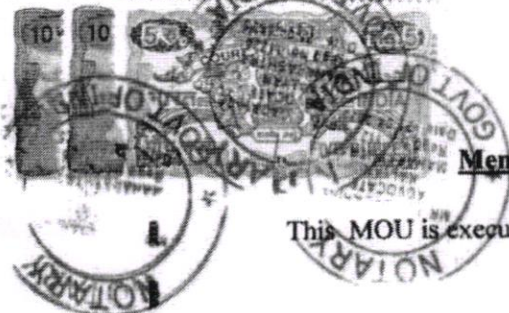

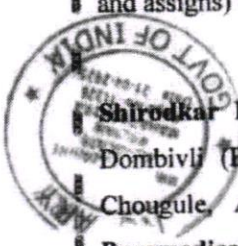
